##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land called Hadden Hill in describe an Advance Tracing No. NU/NWE/2013/21 dated 24th July, 2013, prepared by the Surveyor-General, situated in Hadden Hill Village, Oyapalatha Korale Minor Division, Nuwara Eliya Divisional Secretary's Division, Nuwara Eliya District and bounded as follows:

**01. Lot 'A' – Scrub Estate – Extent: 0.0094 Hectare**
