THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land shown as Lots A - R (Lots 14), Depicted in Advance Tracing No.KU/NRM/2013/043 and dated 15.03.2013, prepared by the Surveyor-General, situated in the Village of Narammala in Minor Division of Udukaha Dambadeni North Korale in the Divisional Secretary's Division of Narammala in Kurunegala District in the North Western Province and bounded as follows:

01. **Lot 'A' – Boogahamulawaththa, Assmt. Nos. 77, 79, 81, 85, 83, 87, 89, 89/1/1, 89/1/2, 91, 91/2 and 91/3 – Extent: 0.0155 Hectare**

North: Lot G; East: Road (RDA); South: Lot E; West: Balance portion of same land.

07. **Lot 'G' – Boogahamulawaththa – Extent: 0.0019 Hectare**

North: Lot H; East: Road (RDA); South: Lot F; West: Balance portion of same land.

08. **Lot 'H' – Boogahamulawaththa – Extent: 0.0077 Hectare**

North: Lot J; East: Road (RDA); South: Lot G; West: Balance portion of same land.

09. **Lot 'J' – Boogahamulawaththa, Assmt. Nos. 107, 107A, 107B and 107/1/1 – Extent: 0.0048 Hectare**

North: Road (Pradeshiya Sabha); East: Road (RDA); South: Lot H; West: Balance portion of same land.

10. **Lot 'M' – Galewaththa – Extent: 0.0209 Hectare**

North: Lot L; East: Balance portion of same land; South: Road (Pradeshiya Sabha); West: Road (RDA).



11. **Lot 'N' – Galewaththa – Extent: 0.0184 Hectare**
 North: Road (Pradeshiya Sabha); East: Balance portion of same land; South: Lot P; West: Road (RDA).

12. **Lot 'P' – Galewaththa – Extent: 0.0028 Hectare**
 North: Lot N; East: Balance portion of same land; South: Lot Q; West: Road (RDA).

13. **Lot 'Q' – Galewaththa – Extent: 0.0024 Hectare**
 North: Lot P; East: Balance portion of same land; South: Lot R; West: Road (RDA).

14. **Lot 'R' – Galewaththa – Extent: 0.0027 Hectare**
 North: Lot Q; East: Balance portion of same land; South: Galewaththa claimed by M. W. A. S. Wijesinghe; West: Road (RDA).
