THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Eight (08) allotments of land in total extent of about 0.0555 Hectare, depicted in Advance Tracing No. KA/BND/12/185 and dated 12.09.2012 prepared by the Surveyor-General, situated in the Village of Gammanpila in the Divisional Secretary's Division of Bandaragama in Kalutara District of Western Province and bounded as follows:
