THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Public purpose : Acquisition of Lands for drainage of Luwisawatta Housing Scheme.

All that Divided and Defined lands in extent of 0.1642 Hectare depicted in Advance Tracing No. Gam/Gam/10/86 dated 29.08.2011 prepared by the Surveyor -General, called Delgahawatta situated at Galtotamulla Village in Medapattu Minor Division of Gampaha Divisional Secretary's Division, Gampaha District in Western province and bounded as follows:
