FILLING OF A VACANCY IN THE MEMBERSHIP OF THE RAMBUKKANA PRADESHIYA SABHA

UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)
AS AMENDED BY LOCAL AUTHORITIES (SPECIAL PROVISIONS) ACT, NO. 30 OF 2013

WHEREAS a vacancy has occurred in the Rambukkana Pradeshiya Sabha due to a member ceasing to hold office by reason of an order of a competent jurisdiction;

A. Dayarathna Bandara, elected as a member of the Rambukkana Pradeshiya Sabha.
