NORTH WESTERN PROVINCE PROVINCIAL COUNCIL

ORDER under Clause 223 of the Pradeshiya Sabhas Act, No. 15 of 1987 read with Clause 02 of the Provincial Councils (Consequential) Provisions Act, No. 12 of 1989.

I, Jayasekara Pathirannahalage Dayasiri Pathma Kumara Jayasekara The Chief Minister and the Minister of Finance and Planning, Law and Peace, Local Government and Human Recourse, Education and Cultural Affairs, Land, Environment, Tourism, Investment Co-ordinate, Co-operative and Food Supply and Distribution of the North Western Province Provincial Council do hereby make the following announcement according to the provisions stated in clause 223 of the Pradeshiya Sabhas Act, No. 15 of 1987 read with clause 02 of the Provincial Councils (Consequential) Provisions Act, No. 12 of 1989.

Order

01. This Order shall be named as the Order to enforce the budget documents for year 2014 of the Pradeshiya Sabhas of the North Western Province Provincial Council.

02. Where the budget documents relevant for year 2014 of a certain Pradeshiya Sabha within the North Western Province was not adopted according to the provisions stated in clause 168 of the Pradeshiya Sabhas Act, No. 15 of 1987 and as per clause 17 of the Local Government Authorities Elections (Amendment) Act, No. 22 of 2012 to fill the Chairmen's office that has become vacant or when a Chairman newly appointed to the vacant position requires to present a proposal to the



Council in relation to adoption of a budget document for year 2014, however, lacks the minimum days to present such proposal to the council in compliance to the written law relevant to that, in such case, it is legal to execute certain budget document prepared for year 2014 by the said Pradeshiya Sabha under the approval of the Commissioner of Local Government of the Province where the relevant Pradeshiya Sabha is located.

03. All the provisions stated in this order shall be put in to effect according to the provisions of the Local Government Authorities (Special Provisions) Act, No. 21 of 2012 and Local Government Authorities Election (Amendment) Act, No. 22 of 2012.

04. These orders should be effective from 01.01.2014.
