TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2) (b) and Section 21(2) (b)

BY virtue of the powers vested in me by Section 6(2) (b) and Section 21(2) (b) of the Town and Country Planning Ordinance (Chapter 269), I, Wimal Weerawansa, Minister of Construction, Engineering Services, Housing and Common Amenities, do by this Order :-

- (a) declare that the area of land specified in schedule hereto shall be an Urban Development Area for the purpose of the aforesaid Ordinance and shall be called “Urapola Siri Medhankararama Sacred Area” ; and
- (b) direct that an outline scheme shall be prepared for the area declared to be the Urapola Siri Medhankararama Sacred Area.

Area Comprising the Urapola Siri Medhankararama Sacred Area
