### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for conservation of Knuckles and will be acquired under the provisions of that Act.

Thirteen (13) allotments of land called Delpatanoya Watta bearing an extent of about 16.586 Hectares, shown as Lot Nos. 01, 02, 03, 04, 05, 06, 07, 08, 09, 10, 11, 12, 13 in the Advance Tracing No. Maha/MDD/98/244 and dated 26th December, 2001 prepared by the Surveyor-General, situated in the Village of Namadagala in Minor Division of Udasiyapattuwa South of Medadumbara Divisional Secretary's Division in Kandy District in Central Province and bounded as follows:

**01. Lot No. 01 – Delpatanoya Watta – Extent: About 0.850 Hectare**

North: Estate Road; East: Lot No. 2; South: Lot No. 2 and Delpatanoya Watta; West: Estate Road.

**02. Lot No. 02 – Delpatanoya Watta – Extent: About 3.420 Hectares**

North: Estate Road, Delpatanoya Watta and Road; East: Road and Lot No. 6; South: Lot No. 6 and Delpatanoya Watta; West: Delpatanoya Watta and Lot No. 01.

**03. Lot No. 03 – Delpatanoya Watta – Extent: About 0.179 Hectare**

**04. Lot No. 04 – Delpatanoya Watta – Extent: About 1.309 Hectare**

North: Mirisketiya Watta; East: Lot No. 5; South and West: Lot No. 3.

**05. Lot No. 05 – Delpatanoya Watta – Extent: About 3.229 Hectares**

North: Mirisketiya Watta; East: Mirisketiya Watta and Lot No. 10; South: Lot No. 10 and Road; West: Lot No. 4.

**06. Lot No. 06 – Delpatanoya Watta – Extent: About 1.132 Hectare**

North: Road; East: Ela; South: Lot No. 7 and Delpatanoya Watta; West: Lot No. 2.

**07. Lot No. 07 – Delpatanoya Watta – Extent: About 0.662 Hectare**

North: Lot No. 6; East: Ela; South: Delpatanoya Watta; West: Delpatanoya Watta and Lot No. 6.

**08. Lot No. 08 – Delpatanoya Watta – Extent: About 0.736 Hectare**

North: Ela and Road; East: Road and Lot No. 10; South: Lot Nos. 10 and 9; West: Ela.



**09. Lot No. 09 – Delpatanoya Watta – Extent: About 1.407 Hectare**

North: Ela and Lot No. 8; East: Lot Nos. 8, 10 and 12; South: Delpatanoya Watta; West: Ela.

**10. Lot No. 10 – Delpatanoya Watta – Extent: About 2.256 Hectares**

North: Lot Nos. 3 and 5; East: Delpatanoya Watta; South: Ela, Lot Nos. 11 and 12; West: Lot Nos. 9 and 8.

**11. Lot No. 11 – Delpatanoya Watta – Extent: About 0.156 Hectare**

North: Ela and Lot No. 10; East and South: Lot No. 10; West: Ela.

**12. Lot No. 12 – Delpatanoya Watta – Extent: About 0.946 Hectare**

North: Lot No. 10; East: Ela; South: Ela, Lot No. 13 and Delpatanoya Watta; West: Lot Nos. 9 and 10.

**13. Lot No. 13 – Delpatanoya Watta – Extent: About 0.304 Hectare**

North: Lot No. 12; East: Ela; South: Delpatanoya Watta; West: Lot No. 12.
