#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for the construction of Deniyaya bus depot and general market and will be acquired under the provisions of that Act.

Allotments of the land situated at Mathugobe Village (f.v.p. 169) of Morawak Korale (West) Minor Division of Divisional Secretary's Division of Kotapola in Matara District in Southern Province depicted as Lots A, B in Advance Tracing No. MR/KTP/2012/670 and dated 09.02.2013 containing in extent of about 0.8819 Hectare and bounded as follows.
