THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land in total extent of about 17.6938 Hectares, depicted in Advance Tracing No.MU/MLL/2012/043 dated 13th August, 2012 prepared by the Surveyor-General, situated in the Village of Kokkulai East in Grama Niladhari Division of Kokkulai East in the Divisional Secretary's Division of Maritimpattu of Mullaitivu District in Northern Province and bounded as follows:

01. Lot 'A' – Kampiththarai – Extent: 1.2752 Hectare

North: Path; East: Remaining portion of Kaddayan Nagamani and Lot B; South: Lots B and C (Path); West: Lot C (Path) and Remaining portion of Kaddayan Nagamani.
