###### Notice under Section 07

I hereby give Notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the land Acquisition (Amendments) Act No. 28 of 1964, that the Government intends to acquire the following land/servitude\* which is required for a public purpose.
