I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude* which is required for the purpose of establishment of Community Centre of Antharawatha Housing Project.
