NOTICE BY THE DIRECTOR GENERAL OF CIVIL AVIATION UNDER THE AIR NAVIGATION REGULATION 196

MEMBERS of the public are hereby notified that this office has received on 22nd April, 2014 an application dated 10th March, 2014 from Fly Southern (Pvt) Ltd. Level 1, S. S. Tower, 92, Glennie Street, Colombo 2, seeking an Air Operator Certificate to engage in Aerial Work Operation, Private Operation, Domestic Charter Operation and Regular Public Transport Operation, International Charter Operations and International Cargo Operation on Schedule basis in compliance with Civil Aviation Act and Regulations made thereunder. Business name of the Company is Fly Southern (Pvt) Ltd. with the trade name as “Fly Southern”. The Directors of the Fly Southern (Pvt) Ltd. are declared as follows.

Members of the public are hereby informed that this office would proceed with the certification process of this application after 04th June, 2014 as per the established procedures to examine the degree of Applicant’s compliance with the applicable Legislative provisions, Air Navigation Regulations, International Standards and Recommended practices specified by ICAO and associated local requirements adopted by this office and ascertain their level of competence for the safe, secure and efficient operation of proposed air services, prior to granting them the requisite Air Operator Certificate and together with other relevant approvals for the commencement of proposed operations.



Any person may, not less than 10 days before the aforementioned date in the penultimate paragraph, make representations to me in writing, setting out the specific grounds on which such representations are made in respect of this application, in accordance with the Air Navigation Regulations. Such representations shall accompany written evidence as to the truth of any statement contained therein. A copy of every such representation shall be sent to the applicant, at the same time as it is sent to this office and a certificate to that effect shall be attached to the representation.
