SABARAGAMUWA PROVINCE PROVINCIAL COUNCIL

Notification made under Section 185 of the Pradeshiya Sabha Act, No.15 of 1987 read with Section 02 of the Provincial Council (Consequential Provisions) Act No.12 of 1989.

By virtue of powers vested in me under Section 185 of the Pradeshiya Sabha Act, No.15 of 1987 to be read with Section 2 of the Provincial Council (Consequential Provisions) Act No.12 of 1989, I, Maheepala Herath, Chief Minister and Minister of Law and Order, Finance and Planning, Local Government, Health and indigenous Medicine, Women Affairs, Co-operatives, Trade and Food, Transport and Estate Welfare, Environment, News, Housing and Construction of the Sabaragamuwa Province have appointed a retired judicial officer as a single person commission of inquiry to ascertain whether the offences mentioned in sub Section 1 of Section 185 of the Pradeshiya Sabha Act, No. 15 of 1987 were committed by Mr. P.P. Wickramasinghe while holding his office as the “Chairman” of the Mawanella Pradeshiya Sabha and in terms of that report it has been decided that Mr. P.P. Wickramasinghe is guilty of one or more allegations under Section 185(1) of the Pradeshiya Sabha Act No. 15 of 1987. After deeply studying the allegations, evidences and decisions of the said report and the allegations, evidences and documents submitted against Mr. P.P. Wickramasinghe, I am satisfied that there are enough evidences to decide that Mr. P.P. Wickramasinghe has committed one or more offences set out in Section 185(1) of the Pradeshiya Saba Act and on satisfying so, I hereby notify that Mr. P.P. Wickarasinghe is removed from the post of Chairman and the post of member, of the Mawanella Pradeshiya Sabha, by virtue of powers vested in me under Section 185(1) of the Pradeshiya Sabha Act No.15 of 1987 to be read with Section 2 of the Provincial Council (Consequential Provisions) Act No.12 of 1989.
