#### FILLING OF A VACANCY IN THE MEMBER OF THE MALIMBADA PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262) AS AMENDED BY LOCAL AUTHORITIES (SPECIAL PROVISIONS) ACT, No. 30 OF 2013

WHEREAS the office of a member in Malimbada Pradeshiya Sabha has fallen vacant by reason of being elected as a member of the Southern Province Provincial Council ;
