### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Two (02) allotments of land in total extent of about 12.5301 Hectares, depicted as Lots 'A' and 'B' in Advance Tracing No. Ma/UKW/2006/291 dated 17.03.2007 prepared by Senior Superintendent of Surveys Matale and situated at Wariyapola Village in Ukuwela Divisional Secretariat in Matale District in Central Province and bounded as follows:

##### 01. Lot "A" – Wariyapolawatta – Extent: 10.4589 Hectares

North: Kandenuwara Road leading from Matale, Channel and Wariyapolawatta claimed by Land Reform Commission; East: Pradeshiya Sabha Road, Wariyapolawatta claimed by R. M. Rambanda and others, Pradeshiya Sabha Road and Railway Reservation; South: Estate Road and Wariyapolawatta claimed by Land Reform Commission; West: Railway Reservation and Kandenuwara Road leading from Matale.

##### 02. Lot "B" – Wariyapolawatta – Extent: 2.0712 Hectares

North: Pradeshiya Sabha Road; East: Channel and Kurulanmaduwe watta claimed by K. H. Elwala and others; South: Wariyapolawatta claimed by Land Reform Commission; West: Kurulanmaduwe watta claimed by K. H. Elwala and others and Wariyapolawatta claimed by K. G. Bodhisena and Others.
