THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude over the land, described below in the 1st Paragraph, is needed for a public purpose and will be acquired under the provisions of that Act. It describes in the 2nd Paragraph, from which land that the servitude will be acquired.

1. **Description of the Servitude.**– Acquisition of Servitude over the land used for laying of pumping main and Distribution lines of Balagolla Water Tank of Kundasale Water Supply Scheme.

THE LAND ACQUISITION ACT (CHAPTER 460)**Declaration under Section 5**
