THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of lands and land Development hereby declare, under Sub-section (1) of Section 5 of the land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.
