SRI LANKA VOCATIONAL TRAINING AUTHORITY ACT, No. 12 OF 1995

Order under Section 27(1)

BY virtue of the powers vested in me by section 27(1), of the Sri Lanka Vocational Training Authority Act, No. 12 of 1995, read with sub-sections (3) and (4) thereof I, Piyasena Gamage, Minister of Skills Development and Vocational Training, in consultation with the Minister in charge of the subject of Lands and Minister in charge of the subject of Finance do by this order declare that the allotments of Lands and the relevant properties described in the Schedule to this order on which the training centre of the Sri Lanka Vocational Training Authority is carried on, be vested with the said Authority for the purpose of the aforesaid Act.
