THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Munasingha Kariyawasam Appuhamilage Don Somadasa Gunawardana, Minister of Lands, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land containing in extent of about 0.0894 Hectare depicted as Lots 'A' to 'F' in Advance Tracing No. KA/BRW/2014/25 dated 30th May 2014, prepared by the Surveyor-General, in the Village of Indiriligoda in the Divisional Secretary's Division of Beruwala in Kalutara District, Western Province and bounded as follows:
