#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Munasinha Kariyawasam Appuhamilage Don Somadasa Gunawardana, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land Called Thannahena Estate in total extent of about 8.3 Hectares, Shown as Lots A, B in Advance Tracing No. MR/PTB/ 2014/ 190 dated 28th August, 2014, prepared by the Surveyor-General, situated in the Village of Pitabeddara (F.V.P. 6) Gramaniladari Division of Thannahena in Morawakorale Minor Division in Pitabeddara Divisional Secretary's Division in Matara District in Southern Province and bounded as follows:
