PROCLAMATION

WHEREAS pursuant to an election held for the election of a President in terms of paragraph (3A) of Article 31 of the Constitution, His Excellency the President Maithripala Sirisena, was declared elected as the President by the Commissioner of Elections, on the Ninth day of January, Two Thousand and Fifteen, in terms of Section 56 of the Presidential Elections Act, No. 15 of 1981 ;

And whereas, in terms of sub-paragraph (d) of paragraph (3A) of Article 31 of the Constitution, the term of office of the President commenced on the Ninth day of January, Two Thousand and Fifteen ;

This Proclamation gives notice of the fact that in terms of Article 32 and paragraph (7) of Article 157A of the Constitution, Maithripala Sirisena Esquire has by making and subscribing the Affirmations set out in the Fourth Schedule and the Seventh Schedule to the Constitution, assumed the office of President of the Democratic Socialist Republic of Sri Lanka for a term of six years, on the Ninth day of January, Two Thousand and Fifteen.
