Municipal Council Regulations

BY virtue of the powers vested in me under Section 2 of Provincial Council (Incidental Provisions) Act, No. 12 of 1989 to be read with Section 289 Chapter 252 of Municipal Council Ordinance, I, J. P. Dayasiri Pathmakumara Jayasekara, the Chief Minister of the North Western Province and the Minister in Charge of the subject of Local Government do hereby impose the regulations relating to the payment of allowances for the Mayor, Deputy Mayor and Members of Municipal Councils. These regulations shall be effective from 01.11.2014.

REGULATIONS

1. These regulations are cited as the regulations relating to the disbursement of allowances for the Mayor, Deputy Mayor and Members of Municipal Councils.
2. A monthly allowances per the below mentioned rates should be paid for the Mayor, Deputy Mayor and Members of Municipal Councils.

Mayor	30,000.00
Deputy Mayor	25,000.00
Members	20,000.00



3. (a) At the following instances the Mayor, Deputy Mayor and Members of Municipal Councils shall not be entitled for allowances.

- i. Being absent at the General meeting and Committee meetings conducted during the month relevant to the payment of allowances without obtaining the approval from the General Council.
- ii. Being remanded or imprisoned on conviction of guilty for any criminal offence.
- iii. Suspension of duties of the Members of any Municipal Council in terms of the Statute of Local Government Authorities (powers of administration and supervision) of the North Western Province No. 01 of 1991 of the North Western Provincial Council or Section 277 of Municipal Council Ordinance.

Provided that in case the period of remand custody, imprisonment, on leave or suspension of service is a part of a month these allowances may be paid for the rest of the month on proportional calculation.

(b) Whatsoever is mentioned in Sub Paragraph (1) of Paragraph (b) of this order a Members' allowances shall not be deprived in case a Member is absent at a Council meeting on a formal approval to perform an official duty.

- i. Being absent at the General meeting and Committee meetings conducted during the month relevant to the payment of allowances without obtaining the approval from the General Council.
- ii. Being remanded or imprisoned on conviction of guilty for any criminal offence.
- iii. Suspension of duties of the Members of any Urban Councils in terms of the Statute of Local Government Authorities (powers of administration and supervision) of the North Western Province No. 01 of 1991 of the North Western Provincial Council or Section 184 of Urban Councils Ordinance.

Provided that in case the period of remand custody, imprisonment, on leave or suspension of service is a part of a month these allowances may be paid for the rest of the month on proportional calculation.

(b) Whatsoever is mentioned in Sub Paragraph (1) of Paragraph (b) of this order a Members' allowances shall not be deprived in case a Member is absent at a Council meeting on a formal approval to perform an official duty.
