The paragraph 2 and paragraph 3 of the Minute on the Sri Lanka Audit Service published in the *Gazette Extraordinary* No. 588/5 dated 11th December 1989 and amended by the *Gazette Extraordinary* No. 993/17 dated 19th September 1997 and No. 1056/23 dated 04th December 1998 have been amended by the Public Service Commission and the amended paragraph are published for information.

By the insertion of

“Special Grade — Annual Salary scale Rs. 508,680 - 12 x 15,720 - 697,320”
above Class I in paragraph 2(I)

By the insertion of

“Special Grade 03 posts”
(Additional Auditor General)
above Class 1 under approved cadre in paragraph 2(II)



Insertion of new paragraph 3(I) above the existing paragraph 3(I)

3(I) Promotion of the Deputy Auditors General in Class 1 Grade 1 of the Sri Lanka Audit Service to the Special Grade.

(a) *Qualifications to be fulfilled*

The promotion of the officers in Class 1 Grade 1 of the service who have fulfilled the following requirements to the vacancies in the Special Grade of the Service will be made only through promotion by the Public Service Commission.

- (i) Has obtained a Postgraduate Degree in Accounts or Auditing (a field of study or as a subject) from a University/ Institute recognized by the University Grant Commission or has obtained the full membership of the Institute of Chartered Accountants of Sri Lanka or the Institute of Chartered Accountants of England and Wales or the chartered Institute of Management Accountants of the United Kingdom or the Institute of Certified Chartered Accountants of the United Kingdom.
- (ii) Has completed an active and satisfactory service period of five (05) years in Class I Grade I of the Sri Lanka Audit Service by the date of becoming eligible and earned five (05) salary increment after the promotion to Class 1.
- (iii) Has completed an active and satisfactory service period of not less than 18 years in the Executive Grade in the qualifying Sri Lanka Audit Service by the date of becoming eligible.
(This paragraph is not applicable to the direct recruits to Class I of the Sri Lanka Audit Service.)
- (iv) Should have had a satisfactory or a higher level of performance for a period of five (05) years immediately preceding the date of becoming eligible for promotion.
- (v) Should have had a satisfactory service period of five (05) years in Class 1 and not being subjected to a disciplinary punishment by the date of becoming eligible for promotion.

(b) *Method of Promotion*

The Promotion of the Deputy Auditor's General of Class 1 Grade 1 of in Sri Lanka Audit Service to the Special Grade only by promotion will be made by in Public Service Commission. The officers who fulfill all the qualifications stated above will be promoted to the Special Grade of the Sri Lanka Audit Service according to the vacancies and on seniority.

(c) *Appointment to the posts of Additional Auditors General*

Insertion of —

“The senior most officers who have served as Deputy Auditors General out of the officers in the Special Grade of the Sri Lanka Audit Service will be appointed to the posts of Additional Auditor General according to the existing vacancies by the Public Service Commission on the recommendation of a Board of Interview appointed by the Public Service Commission.

As a new paragraph 3(I) has been added the existing paragraphs 3(I), (II) and (III) are amended as 3(II), (III) and (IV) respectively.
