THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Munasingha Kariyawasam Appuhamilage Don Somadasa Gunawardana, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Nine (9) allotments of land in total extent of about 18.996 Hectares, depicted in the Advance Tracing No. MAHA/DLT/2013/1346 dated 22nd April 2014, prepared by the Surveyor General situated in the Village of Galaha in the Divisional Secretary's Division of Deltota in Kandy District and bounded as follows:
