### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Munasingha Kariyawasam Appuhamilage Don Somadasa Gunawardana, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Five (05) allotments of land depicted as Lot Nos. 1 to 5 in the Advance Tracing No. CO/DSO/2014/742 of 10th December, 2014 prepared by the Surveyor-General situated in the Village of Udumulla in Divisional Secretary's Division of Kolonnawa in Colombo District of the Western Province and bounded as follows.

##### 01. Lot No. 01 – Bogahawatta, Elamullawatta – Extent: About 0.1465 Hectare

North: Angoda - Kaduwela Road and Madiwela Canal; East: Madiwela Canal; South: Lot No. 5 and Bogahawatta *alias* Elamullawatta claimed by N. N. Pathberiya and some others; West: Bogahawatta *alias* Elamullawatta claimed by N. N. Pathberiya and some others.

North: Ambathale Watta claimed by K. V. P. Gunasekara; East: Ambathale Watta claimed by K.V. P. Gunasekara and Ambathale Watta claimant could not be traced; South: Lot No. 4; West: Lot No. 2.

##### 04. Lot No. 04 – Ambathale Watta – Extent: About 0.0014 Hectare

North: Lot No. 3 and Ambathale Watta claimant could not be traced; East: Ambathale Watta claimant could not be traced; South: Madiwela Canal; West: Lot No. 2.

##### 05. Lot No. 05 – Name of the land could not be traced – Extent: About 0.3418 Hectare

North: Lot No. 1 and Madiwela Canal; East: Madiwela Canal; South: Road; West: Bogahawatta *alias* Elamullawatta claimed by N. N. Pathberiya and some others and Lot No. 1.
