##### THE LAND ACQUISITION ACT (CHAPTER 460)

###### Notice under Section 7

I hereby give public notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following lands/ Servitude which are required for laying of distribution pipes from New Service Reservoir to Hedeniya under the Greater Kandy Water Supply Project.

###### *Description of the land to be acquired:*
