- 5) If a sealed source is imported, letters from the user and supplier that they undertake to return back the source to manufacturer for disposal should be attached.

I am aware of the radiological safety precautions to be observed during the handling of the package and should ensure that all the precautions stipulated by the Atomic Energy Authority will be duly observed.
