ANIMAL DISEASE ACT, No. 59 of 1992

Regulation No. 5(1)

PROCLAMATION

WHERE as foot and Mouth disease has broken out among cattle in Kesbewa Divisional Secretary Division at Colombo District of the Western Province, I Sri Kamal Ranjith Amarasekara, Director General, Animal Production and Health by virtue of the powers vested on me under the Animal Disease Act, No. 59 of 1992, Regulation No. 5(1) do hereby declare the area having the following boundaries as 'Infected area'.

- North - Southern borders of Maharagama Divisional Secretary Division ;
- East - Western border of Homagama Divisional Secretary Division ;
- South - Northern borders of Panadura and Bandaragama Divisional Secretary Divisions ;
- West - Eastern borders of Dhiheiwala-Galkissa and Mortuwa Divisional Secretary Divisions.

Under regulation No. 5(3) of the same Act, I proclaim that no movement of cattle, buffaloes, goats, pigs or cart traffic from and to this area shall be allowed, until this proclamation is revoked.

The attention of all cattle/buffalo/goat/pig owners and carters in this area is drawn to the Animal diseases Act. No. 59 of 1992 which lay down the actions which persons are by law required to take in an "infected Area". Details of these regulations can be obtained from the Government veterinary Surgeon at Kesbewa or the Divisional Secretary at Kesbewa Divisional Secretary Division. This declaration shall take effect from the date hereof.
