APPLICATIONS are invited for the Post of Valuation Inspector Class III Grade III in Sri Lanka Valuation Service in the Department of Valuation. Applications prepared as per specimen form published below should be sent to reach the chief Valuer, Valulation Department, 748, Maradana Road, Colombo 10, on or before 16th September, 2005. Left-hand top of the envelope should be marked as “Application for Post of Valuation Inspector Class III Grade III.”

Note:-

- (i) Applications which are not in the form appended below will be rejected.
- (ii) No allegation that an application form has been lost or delayed in the post can be considered. Candidates who delay their applications until the last few days will do so at their own risk.

02. *Terms of engagement and conditions of service.*—

- (i) The posts are permanent. Selected candidates should contribute to the New Contributory Pension Scheme. The appointments will be on probation for a period of three years.
- (ii) Attention is invited to General conditions applicable to appointment in the Public Service laid down at the beginning of Part 1 : Section (II A) of this *Gazette*.

Except for “recruitments will be made on ethnic ratio” in items 8, all other conditions are relevant.

03. *Salary and Allowances.*— The consolidated salary scale attached to the post is as follows:-

Rs. 126,600—6x1560-13x2,220—164,820 (Efficiency Bars before Rs. 131,280 and Rs. 142,620).

04. *Qualifications.*— Every candidates must furnish satisfactory proof that he—

- (i) is a citizen of Sri Lanka ;
- (ii) is of excellent moral character with good eyesight and sound constitution ;
- (iii) is not less than 18 years and not more than 35 years of age on 16th September, 2005. (the upper age limit will not apply to persons already on Govt. Service/Provincial Govt. Service).
- (iv) has obtained a Degree of a recognized University, or a Degree in Estate Management and Valuation, or Agriculture or in Science of a recognized University.

(Preference will be given to those candidates possessing a Degree in Estate Management and Valuation of a recognized University).

The general conditions applicable to the appointment of Class III Grade III of the Sri Lanka valuation service under 4.7.2 of that service will also apply.

05. *Method of Recruitment.*— Applicants who qualify in terms of the notification will be required to sit for an open competitive examination. Candidates successful at the examination will be interviewed by an Interview Board appointed under section 11.4 of the Minute of the Sri Lanka valuation service, before letters of appointments are given.

Syllabus for the Open Competitive Examination:-

This will consist of two papers.

Paper I

The paper will be based on multiple choice questions relating to economics, Agriculture, Mathematics, and subjects relating to Estate Management.

Time. 20 minutes

Pass marks. 50%

Paper II

This paper shall consist of essay type questions from applied topics in Economics, Agriculture, and Estate Management and allied subjects.

Time: 30 minutes to 1 Hour.

Pass Marks 50%

06. Candidates will be required to produce the following documents when called upon to do so :

- (i) Certificate of Registration of Birth. (N.B.— Baptismal Certificate of Birth issued for the purpose of the Code of regulations for assisted schools will not be accepted.)
- (ii) Certificates of Education/Professional/Technical qualifications.
- (iii) Two certificate of character, one of which should be from the Director, College Tutor or Professor.
- (iv) Certificates of highest examination passed in Sinhala, Tamil and English.

Note.—

- (i) No documents or copies of documents should be attached to the application form.
- (ii) Applications of candidates who fail to produce documents when required to do so will not be considered.
