Esala Festival of Ruhunu Maha Kataragama Devale

Attention of General Public is invited to regulation Governing Pilgrimages to Kataragama framed under the authority of Pilgrimage Ordinance and published in *Gazette* Nos. 9859 dated 30.04.1948, No. 10,000 dated 22.07.1949, No. 11,255 dated 07.02.1958, No. 12,508 dated 07.07.1961 and No. 12,947 dated 02.03.1962 in connection there it is hereby notified that.

01. Camp Area :

'Camp area' means (a) the area within radius of a mile from the afford in the Menik Ganga at Kataragama, and (b) the area

within a radius of a quarter of mile of the Pillayar Kovil at Sella Kataragama.

02. Constructioni of Building :

No person shall construct any building or boutique whether permanent or temporary within the camp area during the period of 07th July, 2005 to 22nd July, 2005 without permit issued by me or any Authorized Officer.

03. Beggars :

No person shall beg or solicit alms within the camp area except in beggars hut situated at near the second pilgrimages' bridge over the Menik Ganga within distance of five yards there from and no person shall distribute any alms to beggars within the camp area except at the aforesaid place.

04. Bathing and Washing :

No person shall bath or wash cloths or animal from the place of water pumping to Kataragama Water Supply Scheme to a distance three miles upwards in Menik Ganga.

05. Vehicle :

5.1 No person shall enter any motor vehicles, bicycles, bullock carts or any type of vehicle to the sacred area. (Eastern part of Menik Ganga) without permit issued by any Authorized Officer or me.

5.2 No person shall park vehicle within the camp area except at place reserved for the purpose.

8.5 All foods exposed for sale should be kept in properly constructed fly-proof cages.

06. Barber Saloon :

No person shall establish any barber saloon within the camp area except at the place, which I have permitted.

08. Selling :

8.1 The hawkers are not allowed to sell anything within the sacred area, pilgrims rest area, bus stand and approach to foot bridge No.01 and 02.

8.2 No person shall sells thinnooru, Ice cream, Pooja wattu, Pooja Bhanda, Food commodities etc., within the camp area except at the place, which I have permitted for the purpose.

8.3 No person shall establish or maintain within the sacred city, any sale, except selling of the flowers shed at the flower sheds already constructed on either sides of road leading to Kataragama.

8.4 Every buildings and every boutique should be provided with a dustbin and all refuses should be deposited therein,
