COMPETITION EXAMINATION FOR RECRUITMENT TO POST OF VETERINARY OFFICER IN THE DEPARTMENT OF WILDLIFE CONSERVATION - 2005

APPLICATIONS are invited from the applicants who possess qualifications indicated in this notification for post of Veterinary officer in the department of Wildlife Conservation.

01. *Terms of Engagement* : This post is permanent. The selected applicants are entitled to a contributory pension under the Contributory Pension Fund. They will be required to contribute to contributory pension as per percentage prescribe by the Government from time to time. If a pensioner who held pensionable post before 01.01.2003 is selected to this post he is further entitled to a pension

under the pension minute and he will be required to contribute to Widows'/Widowers' and Orphans' pension Fund.

03. *Conditions of Service*.- Section from 10 to 12 in chapter 11 of the Establishments code is applicable.

04. *Salary Scale* : Rs. 142,380-15x3,780-199,080 (category T5.1 in the Public Administration Circular No : 09/2004).

Selected candidates should pass the first efficiency bar examination before they reach the salary step of Rs. 153,720 and the second efficiency bar before the salary steps of Rs. 165,060. This efficiency bar examination will be in accordance with Sri Lanka Animal Production and health Services minute Exception from the efficiency bar examination will not be granted on the basis of age.

05. *Educational and other qualifications*:

Every Applicant :

- i. Should be a Sri Lankan who has received citizenship of Sri Lanka either by descent or registration.
- ii. Should be not less than 22 years and not more than 45 years of age on the date of closing applications. the upper age limit will not apply to the officers who are already in the public service and provincial public service.
- iii. Should have obtained a Degree in veterinary medicine from a recognized university and be a registered veterinary Surgeon of Sri Lanka Veterinary Council.
- iv. Should be of excellent moral character and physically fit to serve in any part of the island.
- v. Should be willing to serve in forest areas irrespective of day and night.

06. *Method of Recruitment*.- Eligible persons will be selected subsequent to a written examination and an interview conducted for the candidates.

A. *Question paper on intelligence* : (01 hours duration and maximum 100 marks - A multiple question paper will be given to judge reason power ; analytical ability and decision take capacity.

B. *General Question Paper*:- (02 hours duration and maximum 100 marks - A question paper will be given to test the knowledge of political, social, cultural, economic and environmental activities which are internationally and locally important as well as modern science and industrial development.

07. *How to Apply* :

- 7.1 Applications prepared on the papers of 13"x8" size as per specimen application form published in this notification should be sent by registered post to reach the Director General, Department of Wildlife Conservation. - 7.2 Applications which are not complete in all respects will be rejected and the applicants will not be intimated whether their applications are received or rejected.
- 7.3 Closing date of applications is 18th April, 2005.

All candidates who have paid examination fees and forwarded their applications on or before due date will be allowed to sit the written examination on the prescription that only those who possess qualifications stated in this notification would apply. Issue of an admission card to sit the written examination will not be considered as an acceptance that the candidate has satisfied eligibilities for this post. At the time of examining the qualifications of the candidate at the interview in accordance with the relevant notification if it is revealed that he does not possess requisite qualification his entitlement to appointment will be cancelled.
