APPLICATIONS are invited by the Secretary of the Ministry of Education to fill the vacancies existing in Teacher Educators Service Class 1 at Sri Pada, Addalachchanai, Vavuniya, Uva, Nilwala, Mahaweli, Batticaloa, Pulathisipura, Jaffna, Ruvanpura, Darga Town Colleges of Education functioning under the Ministry of Education.

2. Applications prepared in accordance with the specification form indicated at the end of this Notification should be sent under the registered post addressed to Secretary Ministry of Education Isurupaya, Battaramulla to be received on or before 12.10.2005. The post applied for and the name of the College of Education should be marked on the top left hand corner of the envelope enclosing the application. Applicants employed under Public Service should forward their applications through their Head of the Department. Application receive late will be rejected.

3. Posts in Class 1 in Teacher Educators Service have fallen vacant in Sri Pada, Addalachchanai, Vavuniya, Uva, Nilwala, Mahaweli, Batticaloa, Pulathisipura, Jaffna, Ruvanpura and Darga Town Colleges of Education.

#### 4. Conditions of deployment :

- 4.1 These posts are permanent and pensionable. Those who are already in Public Service will be appointed subject to an acting period of one year.
- 4.2 The provisions in chapter 12.1 and 12.6 to 12.12 in the Establishment Code of the Democratic Socialist Republic of Sri Lanka are applicable.
- 4.3 Should reside within the limits of the College of Education when residential facilities are provided. When such residential facilities are not available they will be allowed to reside within a limited distance. However when residential facilities are provided within the College limits they should occupy in such facilities.
- 4.4 Candidates who are selected for the post are bound to serve in any College of Education based on exigencies of service.

02. Terms of engagement and conditions of Service :
- (i) The Posts are permanent. Selected candidates should contribute to the New Contributory Pension Scheme. The appointments will be on probation for a period of three years.

- (ii) Attention is invited to General conditions applicable to appointments in the Public Service laid down at the beginning of Part I : section (IIA) of this *Gazette*. Except for "recruitments will be made on ethnic ratio" in item 8, all other conditions are relevant.
