#### LIMITED COMPETITIVE EXAMINATION FOR RECRUITMENT TO CLASS III OF SRI LANKA PRINCIPALS' SERVICE - 2005

APPLICATIONS are invited in accordance with the following notification for the Limited Competitive Examination to be held for the recruitment to Class III of Sri Lanka Principals' Service under the Ministry of Education.

The term "service" in this Notification shall mean Sri Lanka Principals' Service and the term "Minutes" shall mean the Minute of Sri Lanka Principals' Service.

#### 01. Date of the Examination and the city.—

- (i) This examination will be held on October 2005. Ministry of Education reserves the right to postpone or to cancel the examination.
- (ii) The examination will be held in examination centers located in the main cities in the following districts. If a number of candidates sufficient for establishing a center is not available please note that such candidates will be referred to a center located in adjacent city.

The Commissioner General of Examination reserves the right to cancel any examination center for which a sufficient number of applicants have not applied.

02. Number of persons to be appointed and the effective date of appointment.— The number of persons to be appointed and the effective date of appointment will be decided by the Public Service Commission. The Public Service Commission reserves the right to fill any number of vacancies or all vacancies or to refrain from filling the vacancies.

03. Conditions of Service.— Selected candidate will be appointed to Class III of the Service subject to conditions stipulated under the Minute of the Sri Lanka Principals' Service published in the *Gazette Extraordinary* No. 1086/26 dated 02.07.1999 of the Democratic Socialist Republic of Sri Lanka and to the amendments to be made in the said Minute hereafter and to the general conditions governing the appointments in the Public Service. After such appointment a place of work will be provided adaptable to the class and duties should be assumed in such place of work. It should be noted that the appointment will be cancelled if duties are not assumed accordingly.

04. *Annual Consolidated Salary Scale - Class III*

Rs. 121,320 – 06x2,460 – 06x3,480—Rs. 156,960.

05. *Eligibility.*— An Officer who hold the following qualifications will be eligible to appear for the Limited Competitive Examination for appointment to Class III of the Service.

- (i) Should be a trained teacher having a period of not less than five years satisfactory service from the date of validity of the Trained Teachers' Certificate or a teacher who has received an appointment upon a certificate accepted by the Ministry of Education as equivalent to the Trained Teachers' Certificate and having not less than five years satisfactory service from the validity date of such certificate ; and
- (ii) Should have been confirmed in the post,

*Note:* An officer who has not earned all salary increments during the period of five years immediately preceding 31.12.2004 and an officer who has been punished of some offence during such period (except warnings) will not be eligible to appear for this examination.

- (iii) An officer who is under interdiction on the closing date of applications will also not be eligible to apply for this examination.

06. *Examination Fee.*— Examination fee is Two Hundred Rupees (Rs. 200). It should be paid at a Divisional Secretary's office, at the General Treasury or at a Post office to be credited to Item 5 Sub Head 2 Revenue Head 6 before the closing date of applications and the receipt received for such payment should be affixed at the cage provided for in the application. This will not be refunded.

07. *Method of Application.*—

- (a) Application should be prepared by the candidate himself in accordance with the specimen form annexed to this Notification by using both sides of 8 1/2" x12" size paper. (Items 01 to 04 should appear in the first page and the remaining items in the other page).
- (b) Candidate should forward the application in the language medium he is eligible to sit for the examination. Apart from the items from (i) to (iv) in first paragraph should be filled in English Capital letters.
- (c) The applications for this examination should be forwarded with the recommendation of Provincial Director of Education/ Additional Provincial Director of Education or Zonal Director of Education or Principal, under registered post to reach on or before 10th October, 2005 addressed to Commissioner General of Examinations, Department of Examinations, Pelawatta, Battaramulla. An officer serving in a school should forward his/her application through the Principal of the school while an officer or Principal who is temporarily attached to an Education Office should forward the application through the Principal or Provincial Director of Education/Additional Provincial Director of Education

or Zonal Director of Education. The words "Limited Competitive Examination for recruitment to Class III Sri Lanka Principals' Service" should be written on the top left hand of the envelope enclosing the application.

- (d) Applications received after the closing date and those which are not complete in all respects will be rejected. Any complaints made relating to applications lost or delayed in the post will not be considered.
- (e) Applications will not be acknowledged and immediately after issuing Admission Cards to the candidates the Commissioner General of Examinations will publish a Notification in the News Papers to that effect. Candidates are requested to be vigilant on such notification and if any candidate does not receive his Admission Card at least seven days before the date of examinations he should notify to that effect immediately to the Commissioner General of Examinations, Department of Examinations, Pelawatta, Battaramulla. along with the following information (Telegraphic address "Exams Colombo") :
  - (i) Name of Examination ;
  - (ii) Candidate's name in full ;
  - (iii) Address ;
  - (iv) Date of posting the application, registered letter number and name of post office.

08. *Appearing for the examination.*—

- (a) Commissioner General of Examinations will issue Admission Cards to all candidates who has forwarded their applications. Every candidate appearing for the Examination should prove his/her identity to the Supervisor of the Examination Hall. A candidate who fails to submit his/her admission card will not be allowed to appear for the examination.
- (b) Candidates should sit for the Examination in the Examination Hall assigned to him/her and hand over the admission card to the Supervisor of the Examination Hall. Candidates' attention is also drawn to the Code of Regulations published by the Commissioner General of Examinations under the General conditions of Appointments to Public Service appearing in the *Gazette* in which this Notification is published.

*Note.*— The issue of an admission card to any candidate should not be treated as an acceptance of his/her eligibility to appear for the examination.

09. *Identity.*— A candidate will be required to prove his/her identity at the Examination Hall to the satisfaction of the supervisor for every subject he appears. For this purpose, only following documents will be accepted :

- (a) National Identity Card issued by the Department of Registration of Persons ;
- (b) A Valid Passport.

10. *Furnishing false information.*— If candidates is found to be ineligible, his/her candidature is liable to be cancelled at any stage prior to, during or after the examination, If any of the particulars furnished by candidate is found to be false within his/her knowledge or if he/she has willfully suppressed any material fact, he/she is liable to be dismissed from Public Service.

11. Regarding any matter not covered by these regulations, The Ministry of Educational use its discretion.

12. *Examination Medium.*—

- (a) This examination will be held in Sinhala, Tamil and English languages ;
- (b) A candidates should appear for this examination only in the language medium that he/she passed the examination or interview that he/she was qualified to enter the Public Service or in the Official Language.

*Note :*

- (i) A candidate should answer every question paper only in the language medium applied for by him/her.
- (ii) Candidates will not be allowed to change the language medium indicated by them in the application.

13. *Method of Testing.*— An examination consisting of written papers in the following subjects and interview of interviews :—

14. *Syllabus.*—

- (i) *Comprehension* - 1 1/2 hours-Question will be to assess the candidates ability to grasp the meaning of a passage or passages.
- (ii) *General Knowledge* - 2 Hours Paper. A question paper to test the candidate's awareness of the environment in which he lives and works including the political, social and technological environment and matters of current national and International interest. A choice of question will be allowed.

15. *Method of Selection.*—

- (a) Selection for appointment will be made based on the merit order of marks obtained at the written examination.

In the event of several candidates obtaining an equal number of marks a decision will be made by the Ministry of Education.

- (b) The number of candidates to be called for the Test for verification of qualifications will be equivalent to the number

of vacancies required to be filled under the ethnic ratio in terms of Public Administration Circular No. 15/90 based on the order of highest marks obtained at the written examination. No marks will be given at the Test held for verifying the qualifications and it will be conducted only for testing basic qualifications, satisfactory service records, certificates and health condition.

- (c) If there are no qualified candidates available under the marks priority list for filling one or more vacancies falling under any ethnic category the Ministry of Education has the right to call candidates who have obtained marks next in the list under such ethnic category for test to verify their qualifications for selecting suitable persons.
