## Examinations, Results of Examinations &c.

### MINISTRY OF SPORTS & YOUTH AFFAIRS

#### Diploma Course in Sports/conducted by the National Institute of Sports Science – 2006

APPLICATIONS are invited from those between 18-35 year of age who wish to study for the Course of Diploma in Sports to be conducted in Sinhala by the National Institute of Sports Science of the Ministry of Sports and Youth Affairs.

1. *Note*.— I. The age limit is not relevant to those who are already in Public Service. Incorrect application will be rejected ;
- II. Applications not completed properly will have to be rejected.

### 2. Educational and Other Qualifications:

- 2.1 Should have passed in 6 subjects at G.C.E. (Ordinary Level) Examination *or* Equivalent Examination in not more than two sittings. However, 2 subjects out of the 6 subjects passed should be Sinhala *or* Tamil and Mathematics *or* Arithmetic.

### 2.2 Further he or she should have.—

- (a) Successfully completed a course at a recognized Government Institution of Sports *or* Physical Education of at least 6 months duration ; *or*
- (b) At least one year service as a Sports Officer attached to the Ministry of Sports and Youth Affairs *or* Provincial Councils or special achievements in sports with at least 3 years service as a Teacher of Sports in Government School *or* as an Instructor/Instructors in Sports of a Local Government Institution ; *or*

- (c) Successfully completed the course in Sports or Physical Education of at least 3 months duration in the Army, Navy or Force training School (could be considered for selection even if not qualified under 2.1); or
  - (d) Being a member of a National Sports Team taken part in competition at international level ; or
  - (e) Obtained first, second or third place in individual events or the National Sports Festival conducted by the Sports Ministry ; or
- first or second places in team championship or first or second place in individual events at inter district competition of this festival and or first place in team events or first second or third place in National level competition conducted by a Sports Federation or first place in a National or Public Schools competition.

### 3. Mode of Application : -

- 3.1 Application who have the necessary educational and other qualifications mentioned above should prepare their application in a paper 8" x 13 1/2" as per specimen application appearing at the end of this notice.

Complete it in their own hand writing and send it by registered post to reach, The Director, National Institute of Sports Science, No. 100/10, Independence Mawatha, Colombo 07. on or before 24.03.2006.

- 3.2 On the top left-hand corner of the envelope containing the application should be written "Application for the Course of Diploma in Sports 2006"
- 3.3 Applicants who are in Government, Local Government and Corporation Services, should forward their applications through the respective Head of Department/Institutions.

### 4. Selection : -

All those who have the necessary qualifications will be called for a written examination and those successful would be called for an interview and practical examination and will thereafter be selected to follow the course.

### 5. Details of the Course : -

- (a) General Theory of Training (Study of the Physical Qualities and Skills, Techniques, Tactics, Training Methods, Aspects of Planning, Principles of Load and Tests) ;
- (b) Theory and Practice of at least ten major sports ;
- (c) Specialization in Track and Field Athletics ;
- (d) Specialization in one Sports or Game, other than Track and Field Athletics which has been offered to the male or female students, either similarly or differently, as the case may be, at the beginning of the course ;
- (e) General subjects involving the study of Sports Physiology and Sociology, Sports Administration Organization Methods and Ceremonials in sports.

- 5.2 The duration of the course is 12 months. (Duration could be changed if necessary)
- 5.3 Those selected to follow the course who are not having jobs should pay a course fee of Rs. 4,500/- and who are having jobs in Government Departments, Corporation or Provincial Councils have to pay a course fee of Rs. 7,500/- by personally or by the institution.
- 5.4 Those who selected are bound by the rules and regulations of the National Institute of Sports Science.
- 5.5 Diploma in Sports Certificates will be awarded to those who successfully complete this course.

### 6. Other Conditions :-

- 6.1 This Ministry is not bound to provide employment to those who complete the course.
- 6.2 But if this Ministry require that those following this Course should enter into an agreement with the Director of the National Institute of Sports Science, they should do so accordingly.
- 6.3 The Director of the National Institute of Sports Science will use his discretion on any matter not specified in this notice.

## COMPETITIVE EXAMINATION FOR RECRUITMENT TO THE POST OF LEGAL OFFICER IN THE MINISTRY OF HEALTHCARE AND NUTRITION

APPLICATIONS are invited from citizens of Sri Lanka with following qualifications for a new post of Legal Officer in the Ministry of health. Applications prepared on form of specimen attached to this letter on a 8 1/2 x 12 inches (foolscap) size paper should be sent under registered post to the following address reach me on or before 03rd April, 2006.

N.B. (i) Applications which do not conform to the form of specimen will be rejected ;

(ii) Applications will not be acknowledged ;

(iii) complaints for delay or loss of an application in the post will not be considered. The applicants should bear themselves the losses, which may occur due to delaying application until the closing date.

02. *Terms of engagement and service conditions :-*

(i) The post is permanent and entitled to a contributory pension, under contributory pension fund. 8% of the monthly earning should be paid as contributions from the date of appointment. The appointment will be subject to a period of probation for 3 years. If an applicant already in the public service is selected to this post, he/she will be appointed on acting basis for a specified period ;

(ii) If during the period of acting his/her services are found to be satisfactory he/she will be confirmed in his/her appointment while if he/she become disqualified to the post during the period of acting he/she will be reverted to his/her former post.

03. *Normal duties attached to the post :-*

(i) To provide necessary legal guidance to this Ministry and attend to the relevant matters where necessary.

04. *Age Limit :-*

Should be over 22 years and below 45 years of age. (The maximum age limit will not apply for persons who are already in the public services).

05. *Educational Qualifications/Alternative qualifications.-*

(i) Should be an attorney at law of the Supreme Court of Sri Lanka with L.L.B. Degree.

(ii) Should be fluent in English and should possess a credit pass for English Language in the G.C.E. (O/L) Examination or a pass any other acceptable English course.

06. *Salary Scale.-* Rs. 224,640 -4x3,960-2x5,640-6x6,780 - 292,440 (in terms of general circular No. 02/130/2005).

07. *Method of Recruitment.*—

Recruitment will be made in terms of circular No. 15/90 of 09.03.1990 based on the results of the written examination and the interview.

08. Entitled to a contributory pension under contributory pension fund should contribute 8% from the monthly earning from the date of appointment.

09. *Service Conditions.*— Section 10 : 12 Chapter II of the Establishments code will apply.

10. *Examination fee.*— Every applicant should pay an examination fee of Rs. 100 by a money order drawn in favour of the Secretary Ministry of Healthcare and Nutrition, “Suwasiripaya” No. 385, Ven.
