(b) Every Tender should be annexed with a certificate of worth issued by the Divisional Secretary of the area in which the immovable properties of the tenderer are situated prospective tenderers are informed that conditions relating to tenders and certificate of worth contained in the above mentioned foreign liquor tavern conditions should be observed very strictly.

The tenderers are also required to pay special attention to ensure that : -
