#### REGULATIONS

Attention is drawn for the public about the Regulations of Kotabowa Pilgrimages, published in the *Gazette* on 24th July, 1964:

01. *Erecting Buildings.*— No person shall without a written sanction of me or any authorized officer erect any temporary or permanent structure or business places within the camp area from 15th August, to 30th August in 2004.

02. *Washing and Bathing.*— No person shall bathe or wash clothes or animals at the Dahamal Oya within the area of 1/2 km. from the Kotabowa Devalaya.

03. *The beggars.*— No person shall beg or solicit alms or no alms shall be given or distributed to the beggars within the camp area or pooja area.

04. *The Vehicles.*— No. motor vehicle, bicycle, bullock cart or any vehicle will driven or entered the camp area (East from Dahamal Oya) without the permission from me or any authorised officer.

4.2 No vehicle shall be kept within the camp area except at such places as may be set apart for the purpose.

4.3 *Kavadi Stalls.*— No person shall establish the Kavadi stalls in any place unless he has obtained a licence in that behalf from me or any authorised officer.

4.4 *Trade.*— No trade within the camp area, poojawa area or Dahamal Oya river shore.

4.5 *Food.*— The food exposed for sale shall be kept in properly constructed fly proof glass cases.
