Land Commissioner's Department Recruitment to the Post of Colonization Officer on Contract basis

APPLICATIONS are hereby called for the recruitment to the Post of Colonization Officer in the Land Commissioner's Department on contract basis. Closing date of applications is 02.02.2004.

02. Eligibility.—Every Applicant,

- 2.1. Should be a Citizen of Sri Lanka ;
- 2.2. Should be of a good character and in sound health ;
- 2.3. Should not be less than 18 years and not more than 45 years on the closing date of applications.

03. Educational Qualifications.— Should have passed the G. C. E. (O/L) Examination in 06 subjects in not more than two sittings, with 04 Credit Passes including Language or Literature, Arithmetic/Mathematics, Science and one another subject or should have passed an examination of similar capacity and should have obtained a Two Years Diploma in Agriculture of a Government approved institution.

Note.— Those who have obtained a Diploma from the Open University of Sri Lanka could be exempted the requirement of passing G. C. E. (O/L) Examination, if they have passed the relevant foundation course.

04. *Salary*.— Rs. 51,840 per annum.

Annual increment - Rs. 1,320

Special allowance (interim payment) approved by the Government will be paid.

05. *Method of Recruitment*.— Selection will be made by calling applications through the *Government Gazette* and on the merits of the competitive examination which will be held in terms of Public Administration Circular No. 15/90.

5.1 Examination consists of two question papers :

Subjects

1. Intelligence Test - (Duration -01 hour - Marks - 100)
2. Technology Question Paper - (Duration - 02 hours - Marks 100)

5.2 *Syllabus* :

1. Intelligence Test :

Part I - Consists of questions, set to test the applicant's logical thinking his analytical ability and decision making ability.

Part II - Consists of two -essay type questions on the Agricultural Economy of Sri Lanka

2. *Technology question paper* :

This Question Paper, will be prepared on the syllabus for the Diploma in Agriculture of Agriculture Schools, approved by the Department of agriculture.

05. *Procedure of Selection*.— Should obtain 40% marks or higher level to qualify in one subject. The applicants who obtain the highest scores at this examination will be called for an interview to check the qualifications, and marks will not be given the interview board those who are having required qualifications and obtaining the highest marks for two subjects, will be selected for the post of Colonization Officer (contract basis).

06. *Terms of Engagement*

6.1 This recruitments will purely be on contract basis, for a period of five years and service will be extended year by year, considering the satisfactory discharge of duties during this 5 year period and at the end of 5 year period, service will be terminated.

6.2 Subjected should be to general conditions, orders and regulations pertaining to the posts on contract basis in public service will applicable.

07. *Examination Fees*.— Every Applicant should pay an examination fee of Rs. 125. A money order, which is drawn in favour of Land Commissioner, to collect from the Post Office, Borella, should be annexed to the application form Examination fees will not be refunded in any case.

08. *Examination Centres*.— Examination centres will be located in Colombo, Matara and Anuradhapura Districts. Unless sufficient number of applications are not received for Matara and Anuradhapura centres the examination will be held only in Colombo.

Every application prepared as per specimen, attached herewith, should be sent by registered post so as to reach Land Commissioner's Department, No. 07, Gregory's Avenue, Colombo 07 on or before 02.02.2004. The words "Post of Colonization Officer External (Contract Basis)" should be written on the top left hand corner of the envelope, containing the application. Applications, received after the closing date will be rejected.

The signature should be attested by placing signature and official frank of a Justice of Peace, Commissioner for Oaths, Lawyer, Notary Public, Principal of a Government School, Staff Officer of public service, Incumbent Thera of a Buddhist temple or any other person who holds a responsible post.

These vacancies exist in the Districts of Anuradhapura, Ampara, Polonnaruwa, Mahiyanganaya, Trincomalee, Batticaloa, Mannar, Kurunegala and Badulla where peasants colonies under Inter Provincial Land Development Schemes of this Department are situated. Hence selected applicants will be posted to those districts.
