POSTS OF CHIEF MEDICAL OFFICER AND DENTAL SURGEON (MALE/FEMALE)

APPLICATIONS are invited by the Sri Lanka Police Reserve from citizens of Sri Lanka for the above posts in the Police Hospital.

02. Applications prepared in accordance with the specimen form given below should be sent by registered post to reach the Director, recruitment, Sri Lanka Police Reserve Headquarters, No. 15, Malalasekara Mawatha, Colombo 07 on or before 21.02.2004. Applications received thereafter will be rejected. The post which you apply should be written on the top left hand corner of the envelope. Preference will be given to those who are in Government Service at present.

03. Post of Chief Medical Officer :

- * Reserve Senior Superintendant of Police.
- * Reserve Woman Senior Superintendant of Police.

(i) Age.— Not less than 40 years of not more than 50 years.

(ii) Educational of Professional Qualifications :

- (a) MBBS (SL) or equivalent medical degree, permanent and full registration by the Sri Lanka Medical Council.
- (b) Grade I medical Officer with a post-graduate Diploma/ Degree. Preference will be given to those candidates with M. Sc. Medical Administration.

(iii) Experience.— Not less than three years experience in hospital administration in charge of a base hospital or a higher institution.

(iv) Salary/Other Facilities :

- (a) The selected candidate will receive the Health Department salary with due increments and allowances. In addition he or she will receive some of the allowances due to the mobilized officers of the Police Reserve.
- (b) An official car and a driver will be provided.
- (c) Married quarters will be provided within the Hospital premises.

(v) Terms of Employment :

- (a) The selected candidate will be enlisted and mobilized as RSSP/RWSSP in the Sri Lanka Police Reserve and will abide by the rules and regulations applicable to the Police Reserve.

- (b) The selected candidate will continue to maintain his or her service seniority in the Health Department.
- (c) The selected candidate will have to serve a probationary period of one year. And he/she will be kept mobilized for service only as long as his/her services are required.

04. Post of Dental Surgeon :

- * Reserve Assistant Superintendant of Police.
- * Reserve Woman Assistant Superintendant of Police.

(i) Age.— Below 35 years.

(ii) Educational and professional Qualifications :

- (a) BDS (SL) or equivalent ; with permanent and full registration by the Sri Lanka Medical Council.
- (b) With at least six months experience of work under a Consultant Orthodontist.
- (c) Preference will be given to those who had obtained a Distinction pass in Orthodontics at the BDS final examination.

(iii) Salary/Other Facilities :

- (a) The selected candidate will receive the Health Department salary with due increments and allowances. In addition he or she will receive some of the allowances due to mobilized officers of the Police Reserve.
- (b) An official Car and a Driver will be provided.

(iv) Terms of Employment :

- (a) The selected candidate will be enlisted and mobilized as RASP/RWASP in the Sri Lanka Police Reserve and will abide by the rules and regulations applicable to the Police Reserve.
- (b) The selected candidate will continue to maintain his or her service seniority in the Health Department.
- (c) The selected candidate will have to serve a probationary period of one year. And he/she will be kept mobilized for service only as long as his/her services are required.

05. Conditions of Service :

- (a) The selected candidates will be required to comply with any rules already made or may hereafter be made to give effect to the language policy of the Government.
- (b) Candidates will be subject to the regulations stipulated in the Established Code and the regulations issued from time to time by the Inspector General of Police or the Government.

- (c) Applicants selected, should pass Medical Examination prior to securing of appointments. Those who are found unsuitable for Police Service will be rejected.

06. (i) The Applicants should attach copies of the following documents to their applications (Originals should not be attached) :

- (a) Birth Certificate ;
- (b) Certificates confirming Educational Qualifications ;
- (c) Professional Certificates ;
- (d) Certificates regarding the service experience.

(ii) Applicants must fill the required particulars in their own hand writing on papers 11" x 8" in size and post them, together with the copies of certificates called for, to the address given in paragraph 2. Under no circumstances should applications be handed over personally to any officer in the Police Department.

Note.— All applications which do not conform to the requirements stipulated in this notification will be rejected and such applicants will not be notified. Travelling expenses will not be paid to candidates who are summoned to appear for the tests and interviews.
