**NOTICE UNDER SECTION 20 OF THE CEILING ON HOUSING PROPERTY LAW, No. 1 OF 1973 AS
AMENDED BY CEILING ON HOUSING PROPERTY (AMENDMENT) LAWS, Nos. 34 OF 1974,
18 OF 1976, 9 OF 1977 AND 56 OF 1980**

WHEREAS by the operation of the provisions of the Ceiling on Housing Property Law, No. 1 of 1973 as amended as aforesaid, the house morefully described in the Schedule hereto are vested in me;
