

Notice Calling for Tenders

Laundering of Soiled Linen - 2005

SERVICES and Persons Eligible to Tender.—The Director, The National Hospital of Sri Lanka, Colombo 10 will receive separate sealed tenders from Citizens of Sri Lanka or Sri Lankan firms for the Laundering of soiled linen for the period from 01st January, 2005 to 31st December, 2005 (both days inclusive) to the institutions mention in column 01 of the schedule hereto.

02. (i) *Tender Deposit.*— A cash deposit of the sum specified in column 2 of the schedule hereto should be made at the National Hospital of Sri Lanka to the credit of the Director and a receipt should be obtained. approved Rural Development Societies may apply for tender forms without making tender deposits. They should however, furnish the registration number when apply for tender forms.

(ii) *Tender Forms.*— Tender forms will issued upto 12.00 noon prior to the date of closing of tenders at this office. No Tender will be considered unless it is on the appropriate forms. The receipt issued for the tender deposit should be attached to the application for tender forms.

(iii) *Applications.*— For the tender forms by post should be sent to me as early as possible to enable the prospective tenderers to obtain the forms and submit their tenders before the closing date and time.

03. *Particulars of Wealth :*

- (i) All tenderers should furnish particulars of their wealth to me in advance of the closing date of the tender forms for this purpose could be obtained from the office.
- (ii) Failure to furnish the particulars of wealth or to prove financial status may result in forfeiture of the tender deposit.

04. *Particulars of Number of Places to be Washed.*— Particulars regarding the appropriate number of pieces required to be washed per month are given in column 5 of the schedule hereto.

05. *How the Tender should be Forwarded.*— All tenders should be forwarded in duplicate and be enclosed in a cover addressing to the Director, National Hospital of Sri Lanka, Colombo 10.

The nature of the Service/Section applied should be on the top left hand corner of the sealed cover enclosing the tender and the name and address of the tenderer at the left bottom corner of the cover. Sealed tenders can be sent to me by registered post or inserted into the tender box kept in the Chief Accountant's Office.

06. *Closing of Tenders.*— Receiving of tenders will be closed 10.00 a. m. and opened immediately thereafter as per the date given in column 6 of the schedule.

07. *Opening of Tenders.*—Tenderers may present when the tenders are opened. The names of the tenderers as well as the rates will be read out to the tenderers who present at the opening.

08. *Validity of Tendered Rates.*— The rates quoted by the tender should valid for the period of contract mentioned in the para 01 above and in no circumstances will the rate may be permitted to varied during such period, unless specifically provided for in the agreement.

09. *Security Deposits.*—The selected tender will be required to sign an agreement within 10 days of the acceptance of the tender after furnishing the required security mentioned in column 03 of the schedule hereto.

10. *Tender Conditions.*— Prospective tenderers should study the tender conditions on the reverse of the tender form and comply with requirements therein.

Tenders should have five (05) years experience about laundering of soiled linen in a epidemiology hospital.

11. *Other Particulars :*

- (i) If the contractor is provided with facilities of store rooms, electricity, water etc. A monthly charges will be paid for the transport of soiled linen from the institution to the disinfecting station and return.

- (ii) *Disinfecting Soiled Linen and Transport Charges.*— In case it is required that the soiled linen be disinfected before it is washed, no transport charges will be paid for the transport of soiled linen from the institution to the disinfecting station and return.
