Firms which wish to tender,

- (i) Should be registered with the Ministry of Defence as agencies approved for the Provision of Security Services for Government Departments.
- (ii) Should have satisfactorily carried out security services to the value of Rs. 100,000 or over per month during the past five years in Government Departments and Ministries and should still be engaged in similar services. (Documentary proof should be provided).
- (iii) Should have minimum of a hundred trained and experienced personnel for which proof should be provided by means of documents for E. P. F. contributions and any other documentary evidence.
- (iv) Should have personnel with acceptable physic within the age limit of 20 - 60 years possessing satisfactory experience in the fire fighting and handling fire arms ; and
- (v) Should provide documentary proof of financial stability with bank reference.

All tenders in duplicate on the appropriate form addressed to the District Secretary, Kalutara must either be sent by registered post or deposited in the tender box provided for the purpose in the room of the Additional District Secretary at the District Secretariat, Kalutara before 3.00 p. m. on or before 22.05.2004.
