SALE OF TODDY TAVERN RENTS — DIVISIONAL SECRETARY'S DIVISION, LUNUGALA — 2005

TENDERS will be received by the Divisional Secretary, Lunugala till 10.00 a.m. on 21st of October, 2004 for the purchase of the exclusive privilege of selling fermented toddy by retail at the toddy taverns given in the Schedule below during the period of 1st of January, 2005 to 31st of December, 2005 subject to the Rent Sales Condition published in the *Government Gazette of the Democratic Socialist Republic of Sri Lanka* No. 207 of 20th August, 1982 and to the General Conditions applicable to the Excise Licences for the time being in force, and to the following conditions.

02. Duly perfect tenders in the prescribed forms, which may be obtained at any Divisional Secretariats, by the tenders must be accompanied by the Divisional Secretariat receipt, acknowledging the receipt of the fixed deposit indicated in the Schedule hereunder, together with a Certificate of Worth obtained in terms of the Toddy Rent Sales Conditions published and enclosed in a sealed envelope, in the left-hand corner or which should be clearly written the name and the number of the toddy tavern as appearing Schedule in respect of which the tender is made and placed in the tender box kept in this Divisional Secretariat, Lunugala on or before the date and time prescribed in the Schedule for closure of tenders.

03. All alternations or corrections made in the tender form must be authenticated by the tenders by placing his signature against which alternations of correction. Tenders of those which do not comply with those requirements will be rejected.

04. All tenders should be present at this Divisional Secretariat at 10.00 a.m. on 21st of October, 2004, which date in the last date of closing on tenders.

05. The Divisional Secretariat, Lunugala reserves to himself the right of rejecting any one or all the tenders without assigning any person therefore.

06. Re-sale will be held at 10.00 a.m. 06th of December, 2004 for the unsold taverns. If any subject to the same requirements appearing in this *Gazette Notice*.

07. On being declared the purchaser of the privilege successful tender should not later than 2.00 p.m. on the day of which he is declared to be the purchaser, pay to the Divisional Secretariat, Lunugala as security deposit such sums as any be specified by the latter, being a sum greater than two months rent for the privilege and sign the Rent Sales Conditions.
