### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, the Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

Twelve portions of land with following boundaries, names and extents, depicted as Lot. No. 01 to 12 in the Plan No. 293 and dated 19.10.1995 of the Licensed Surveyor Mr. A. K. Ananda W. de Silva containing total extent about 0.3395 Hectare, situated in vilages of Nagollagama and Egodawelagama in the Minor Division of Soranatota Korale in the Divisional Secretary's Division of Soranatota in the District of Badulla.

**1. Lot No. 1 – Puranekumburawatta – home garden – Extent: 0.0067 Hectare**

North: Balance portion of the same land; East: Lot No. 2; South: Lot No. 2 and Highway; West: Highway.

**2. Lot No. 2 – Puranekumbura – paddy field – Extent: 0.0176 Hectare**

North: Balance portion of the same land; East: Balance portion of the same land; South: Lot No. 3; West: Highway.

**3. Lot No. 3 – Kadapahiyakumburawatta – paddy field – Extent: 0.0210 Hectare**

North: Balance portion of the same land; East: Balance portion of the same land; South: Lot No. 4; West: Highway.

**4. Lot No. 4 – Kadapahiyakumbura – paddy field – Extent: 0.0220 Hectare**

North: Lot No. 3 and balance portion of the same land; East: Balance portion of the same land; South: Lot No. 5 and 6; West: Highway.

**5. Lot No. 5 – Gannilekumbura – paddy field – Extent: 0.0067 Hectare**

North: Lot No. 4 and balance portion of the same land; East: Balance portion of the same land; South: Lot No. 6; West: Lot No. 6.

**6. Lot No. 6 – Gannilekumbura – paddy field – Extent: 0.0530 Hectare**

North: Lot No. 4 and 5; East: Balance portion of the same land and Lot No. 5; South: Lot No. 7 and Highway; West: Highway.

**7. Lot No. 7 – Gannilekumbura – home garden – Extent: 0.0067 Hectare**

North: Lot No. 6; East: Balance portion of the same land and Lot No. 5; South: Lot No. 8; West: Highway.

**8. Lot No. 8 – Mulathakumbura – home garden – Extent: 0.0155 Hectare**

North: Lot No. 7; East: Balance portion of the same land and Lot No. 5; South: Lot No. 9 and Highway; West: Highway.

**9. Lot No. 9 – Mulathakumbura – home garden – Extent: 0.0170 Hectare**

North: Lot No. 8 and balance portion of the same land; East: Palugama stream; South: Highway; West: Highway and Lot No. 8.

**10. Lot No. 10 – Godapitahena – home garden – Extent: 0.0934 Hectare**

North: Highway; East: Highway and Lot No. 11; South: Balance portion of the same land; West: Highway.

11. **Lot No. 11 – Uhanawatta – home garden – Extent: 0.0395 Hectare**

North: Highway and Lot No. 12; East: Balance portion of the same land; South: Balance portion of the same land; West: Highway.
