THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Anura Kumara Disanayaka, Minister of Agriculture, Livestock, Lands and Irrigation hereby declare under Sub-section (1) of Section 5 of the land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act:

Twenty Seven allotments of land in total extent of about 0.0764 hectare, depicted in Advance Tracing No. 95/363 of 18. 04. 1996 prepared by the Surveyor - General situated in the village of Walagedara in the Divisional Secretary's Division of Matugama in Kalutara District and bounded as follows:
