THE NATIONAL HOUSING DEVELOPMENT AUTHORITY ACT, No. 17 OF 1979

Certificate under Section 06

A block of land approximately 22.4 Perches in extent out of land called Puwakgahakotuwa and Millagahakumbura, situated at Gramaseva Niladhari Division of Galtotamulla, Divisional Secretary's Division of Gampaha, Gampaha District, Western Province and bounded as follows :

North : by Portion of Puwakgahakotuwa and Midellagahakumbura ;
East : by Ela ;
South : by Ela ;
West : by Galtotamulla Kirikitta Road.
