THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Dissanayake Mudiyanseelage Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for Knuckles Conservation Zone and will be acquired under the provisions of that Act.

Declaration under Section 5

I, Dissanayake Mudiyanseelage Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude described in para. I is required for a public purpose and will be acquired under the provisions of the Act. The land over which the said servitude is to be acquired is given in para II.

THE LAND ACQUISITION ACT (CHAPTER 460)**Declaration under Section 5**

I, Dissanayake Mudiyanse Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation, do hereby declare under Sub-section 5 of the Land Acquisition Act, that the servitude described in Para I is required for a public purpose and will be acquired under the provisions of that Act. The land over which the said servitude is to be acquired is given in Para II.

1. **Description of servitude.** – Servitude for the laying and maintenance of pipelines.
