CUSTOMS NOTIFICATIONS

The Customs Ordinance (Chapter 235)

ORDER UNDER SECTION 10A

BY virtue of the powers vested in me under Section 10A of the Customs Ordinance (Chapter 235) as amended by Act, No. 83 of 1988, I, Sarath Amunugama, Minister of Finance and Planning with the approval of the Cabinet of Ministers, do by this order levy on all imported goods except those specified in Schedule hereto, a surcharge of 10% on Customs Duty, both General and Preferential, from 01st January, 2005 till 31st December, 2005.

SCHEDULE

The above order under Section 10A of the Customs Ordinance shall not apply to the following goods falling under the following Chapters, Headings and Sub-Headings of the Customs Tariff, being Schedule "A" to the Customs Ordinance (Chapter 235).
