THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Disanayake Mudiyanseelage Anura Kumara Dissanayake, Minister of Agriculture, Livestock, Lands and Irrigation, hereby declare under sub-section (1) of section 5 of the Land Acquisition Act, that the land described below as needed for a public purpose and will be acquired under the provisions of that Act.

Four (04) allotments of land in total extent of about 0.3256 Hectares, as Lot 01 to 04, depicted in Advance Tracing No. KA/SGO/03/533 and 04.12.2003, prepared by the Surveyor General situated in village of Paragastota in Minor division of Raigam Korale in the Divisional Secretary's Division of Millaniya in Kalutara District and bounded as follows.
