FAUNA AND FLORA PROTECTION ORDINANCE (CHAPTER 469)

Order under Section 2

ORDER made by the Minister of Environment and Natural Resources under sub-section (4) (a) of Section 2 of the Fauna and Flora Protection Ordinance (Chapter 469).

The limits of the area of State land declared as the Bundala National Park by Order published in the *Gazette Extraordinary* No. 748/3 of 04th January, 1993 is hereby altered by the substitution for the Schedule of that Order of the following Schedule.
